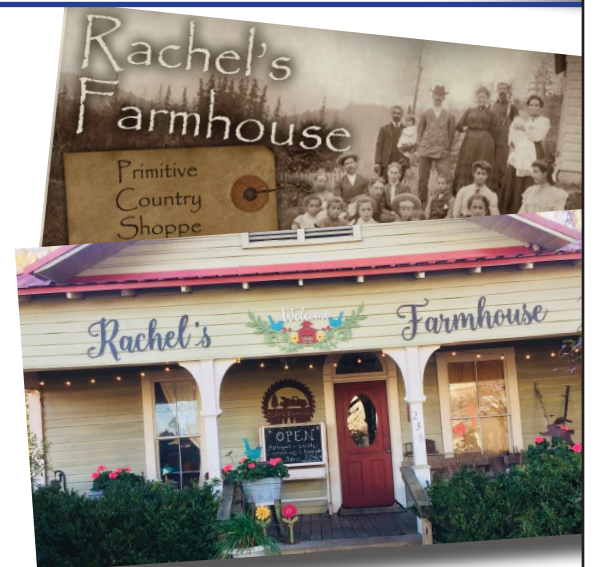

S2A MODULAR TO BUILD FIRST EAST COAST MEGAFACTORY IN MACCLENNY

S2A Modular – creator of the first electrically self-sustaining, custom and smart-connected GreenLux™ luxury residences and commercial buildings – has purchased 51 acres of land for its first East Coast MegaFactory in Macclenny, FL, 30-miles west of Jacksonville. The site is located in the Enterprise East Industrial Park, currently home to a major Walmart distribution center as well as several other small and medium-size businesses. Once operational, the company's third MegaFactory will feature approximately 13 buildings and structures totaling more than 240,000 square feet. The factory is expected to generate more than \$80 million of economic impact to the region – and an additional \$60 million in secondary impact due to the scale of its operations.

“The entire S2A Modular team is extremely excited to announce the location of our third MegaFactory in Baker County, and our first on the East Coast,” said Brian Kuzdas, CEO and co-founder of S2A Modular. “We are grateful to Darryl Register, executive director of the Baker County Chamber of Commerce and James Bennett, county commission chairman, for their work helping us find the perfect factory location. They were instrumental in finding shovel ready property which allows for the rapid construction of our MegaFactory and subsequent production of thousands of sustainable, affordable luxury homes for this region.





“Northern Florida is a prime location for us to help usher in the GreenLux™ revolution – lowering the cost of living and raising the standard of living through electrically self-sustaining luxury smart homes and smart commercial buildings,” Kuzdas continued. “Our homes and commercial structures are engineered to be the lowest amperage, lowest voltage buildings on Earth and we look forward to making a significant long-term impact to city of Macclenny, Baker County and the city of Jacksonville.”

The land purchase in Macclenny was orchestrated with the help of the Baker County Economic Development Council and the Baker County Chamber of Commerce. Located near Interstate 10 and several major state highways, Enterprise East Industrial Park’s location offers S2A Modular several strategic advantages including access to a large skilled workforce, international airport, major rail lines and a rapidly growing population.

“As the county commission chairman, we are very excited to have S2A Modular choose Baker County as the location for their new manufacturing facility,” said James Bennett, county commission chairman. “The sustainable aspects of the company, their products and the

quality jobs they are creating are a great fit for Baker County and our region.”

When fully operational, the world-class facility will manufacture annually 5,000 revolutionary GreenLux™ luxury smart residences, smart commercial buildings, hotels and multifamily units. The establishment of a MegaFactory in Macclenny, in addition to the company’s MegaFactories in Patterson and Hemet, is part of S2A’s rapid expansion plan to build a total of 35 MegaFactories across the nation by 2025. With S2A present within a region, home buyers and real estate developers will have ready access to higher quality, energy-efficient homes, hotels, multiuse facilities and commercial buildings produced in a climate-controlled factory using technologically advanced construction techniques. Economic development will be delivered from both the manufacturing facility, as well as the buildings that are manufactured there. S2A Modular currently has a rapidly expanding order pipeline of 100,000 homes and commercial buildings nationally.

“On behalf of the entire chamber of commerce, I am honored to officially welcome S2A Modular to Baker County,” said Darryl Register, executive director of the Baker County Economic Development Council. “I thoroughly enjoyed helping them find the perfect location for their first East-Coast MegaFactory and am really looking forward to seeing its positive impacts on Baker County. Affordable, sustainable housing is definitely needed in this region and I am very impressed at how they are able to use renewable energy and new technologies to solve many of the issues facing our society.”

S2A Modular plans to break ground late June of 2021.

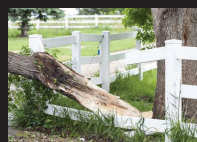

Town of Glen St. Mary

Town History

Even though it was founded as a township in 1881, Glen St. Mary's rich history dates back to its earliest known inhabitants, the Timucuan Indians. They inhabited this area until the early 1700's when they were replaced by the Creeks and Seminoles, who drifted into this area and settled. At the end of the Second Spanish Period, a different settler moved in – American pioneers. Relentlessly, this new pioneer slowly, but ever so surely, eased in and crowded the Native Americans out.

Considered the first permanent white settlers in Glen, Daniel John Mann and his wife, LeVicy, arrived in 1829. They set up housekeeping among the Native Americans and began to work the land. In the same year, another pioneer by the name of John Barber settled here. He was killed before the end of the year in a pre-dawn Native American attack. Many other pioneers closely followed – some digging in to stay a while, others eventually moving on.

By 1850, this area was known as the Cotton Field, becoming even more populated because of the vital crop. After the Civil War, however, there was a great shifting of the population, and those once-productive fields were largely abandoned. They were picked up for taxes by a new influx of Northerners and displaced Southerners from the Old Dominion and the Carolinas. Charly W. Turner, a native of New York arrived in May of 1869. He constructed a small sawmill lumber house on the present site of the Glen Nurseries. Most of the land in the area at that time was controlled by a Mr. James Barnett, a lumber and naval stores operator.

After the rediscovery of Florida during the post-Civil War boom, a young Chicago stockbroker came to Florida in 1881 on the advice of his

physician. Touring the countryside, he fell in love with the area. He purchased a tract of land off the St. Mary's River and began to plant an orchard. Becoming interested in the plant industry, he formed a partnership with Thomas Beath in 1882 and began the Glen St. Mary Nursery Company, starting out with 1,600 acres of abandoned cotton fields. Soon after Mr. Beath left the business, the company began to grow. George Taber became a charter member of the Florida State Horticulture Society and served as its president.

Since 1881, the Glen St. Mary area had grown to such proportions that by 1885 the Board of County Commissioners set up a committee composed of Charles Eiserman, W.H. Congleton, H.L. Reed and George Taber to divide the area of land separating Sanderson from Darbyville. This new district would become officially known as Glen St. Mary, District No. 5. Local historians credit Taber for having named the township.

After a disastrous freeze in the late 1890s, Taber refused to move his business to warmer climates. He encouraged other growers to stay in north Florida – determined more than ever to develop cold tolerant plants and learn new ways to protect plants from the cold. As a result of his dedication and hard work, thousands of acres in Florida had their beginning at the Glen St. Mary Nursery. The nursery expanded its operation to South Florida allowing it to supply plants throughout the Southeastern United States, Central and South America, China, India, Spain and Russia. The Rio Grande Valley of Texas began growing citrus with Glen stock. The Satsuma Orange, Temple Orange, Kumquat, Weaver Dogwood and the Magnolia St. Mary all originated at the Glen St. Mary Nursery. One of our proudest symbols is the George L. Taber Azalea.

While vacationing in North Florida, Ohio resident Alverdo Geitgey was so

impressed with the community that he eventually invested in 12,700 acres of Baker County land making him the first real estate developer. Plotting out the town, he named the streets after U.S. presidents and some of Glen's horticultural products. His real estate pamphlets, many being sent north by the Taber family's influence, lured buyers from all over, directly affecting the economic surge of growth to the community.

At the turn of the century, Glen St. Mary was a thriving little town. Within the township limits were at least three boarding houses, two general stores, a doctor's office with pharmacy, a train depot, an ice-cream parlor, a livery stable, a cotton and lumber mill, a large strawberry farm, a boom citrus and lumber industry, a non-alcoholic billiard hall, various churches and their crowning

glory, the Glen St. Mary Nursery. All of this industry took place south of U.S. Highway 90, then just a dirt road.

It was a time when businesses, professional offices and families peacefully co-existed and prospered within Glen St. Mary. The townspeople worked hard, played hard and were proud of where they lived. Even in its heyday, it was still quite homey, with large oak trees lining our main street, planted by one of the most successful pioneering families, the Tabers.

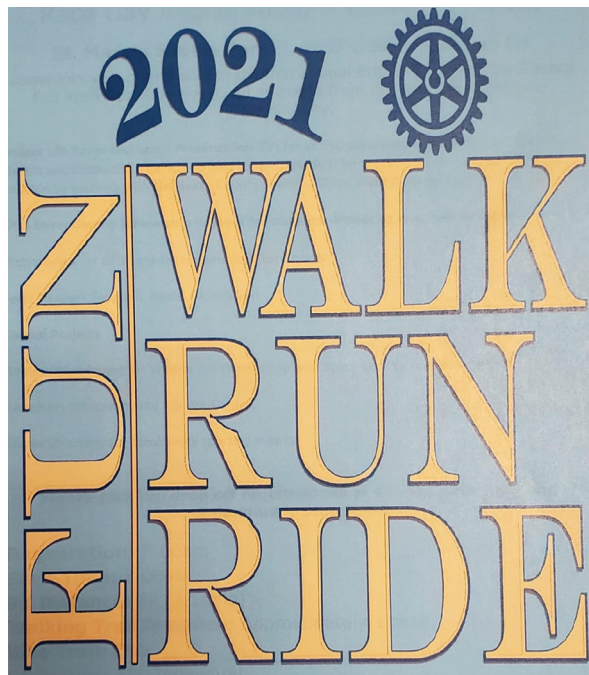

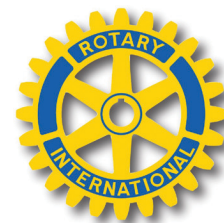

HERITAGE PARK VILLAGE



A unique collection of community history showcasing the lives and traditions of generations from residents of Baker County, Florida.

Baker County, established in 1883 in northeast Florida is an area of rich history and colorful traditions. Many of the county's current residents are direct descendants of the pioneering families that settled in the 1800s. The legacy of those families and the pioneer spirit and traditions they have passed down is today is preserved in the county's history here at Heritage Park Village.



Come and leisurely stroll along a horseshoe-shaped cement path that winds past numerous mini museums. Each museum showcases exhibits highlighting this unique slice of Florida community history including the county's fascinating moonshine era. In the beautifully restored Burned Blockhouse, the last of its kind remaining in the state of Florida, get an up close look at the architecture of early pioneer life. Note the rough, hand-hewn timbers, rambling outdoor porches and detached country kitchen with its chimney constructed of moss and mud.

Heritage Park Village was designed to house Baker County's History, from its known documented beginnings through the year 2000. Its primary purpose is also to provide a place for Baker County families to reflect, reminisce and honor their ancestors and unique heritage as well to help visitors connect with the county's history.



THE LEGACY OF BAKER COUNTY



In 1829, the first documented wagon train arrived in the area bringing with it the Hogan, Barber, Drigger and Greene families. During the 1850s a community known as Darbyville, named for Colonel John Darby, was established. John Darby was a prominent merchant and owned a sawmill operation. Over the years, the county lines shifted numerous times but in 1861, Baker County was finally established. Darby's daughter Ada married Carr McClenny, an industrious



and enterprising young man.. Eventually Darbyville became known as McClenny. Descendants of this original McClenny family still spell their name in the original spelling. Long ago, a post master changed the spelling to Macclenny, eliminating the Capital C used in the original name. Heritage Park Village uses the original spelling.

Since those days and through the decades of the 20th century, McClenny has changed a great deal. But the one thing that has never changed is the tight-knit sense of family. The 20 heritage museums located on the park grounds are testimony to the history, industry and traditions of the people of Baker County. They are designed, not as literal recreations, but to give a broad overview of the development of the community and showcase original items such as photographs, scrap-books, oral testimonies and other artifacts which help recount our citizen's histories.

Heritage Park Village owes its establishment and existence to many community visionaries who believed in the project and contributed generously of time and funding to make it happen. The park's many volunteers who have given unselfishly over the years and continue to play a vital role in its upkeep and management are a treasured resource as well.

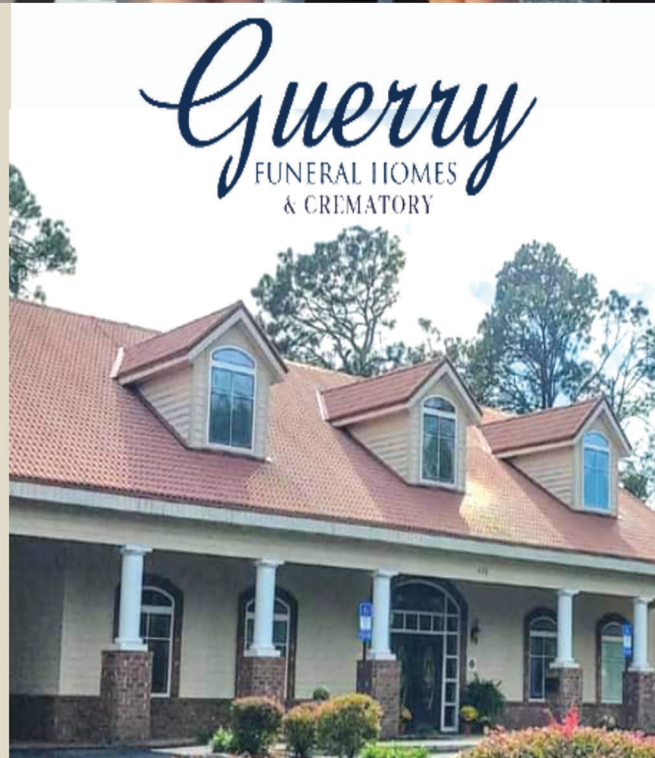

Olustee Battlefield

In the early days of 1864, Gen. Truman Seymour arrived in Jacksonville (which had been seized by the Union two years earlier) to occupy North Florida and cut off the line of supply from the state to the other rebel armies. Gen. Seymour sent cavalry raiders began to harass the inland towns of Lake City and Gainesville to sever the Confederacy's railroad lines.

Confederate General Joseph Finegan had 500 at Lake City to stand against General Seymour's force of 5,500, as skirmishes began around the Olustee railroad station, near Ocean Pond, in what is now western Baker County. By the time the battle began in earnest, on February 20, 1864, the Confederates had 5,000 men.

The battle was fought in the pine forests, and raged throughout the day until the Union lines broke late in the afternoon. A retreat was supported by rear-guard action by the 54th Massachusetts Regiment and the 35th U.S. Colored Troops, both composed of African-American enlisted men. (The 54th Massachusetts Regiment had, six months earlier, fought a famous battle for Fort Wagner in South Carolina, commemorated in

the Academy Award-winning movie *Glory*. Scenes for the movie were filmed at Olustee Battlefield Historic State Park.)

The Union army retreated to Jacksonville, with 1,800 casualties. The Confederate Army had 900 casualties. The battle of Olustee was described later by soldiers from both sides as some of the fiercest fighting they experienced in the war. For the Union side, it was the one of the bloodiest, in terms of the percentage of men engaged who were killed, wounded or missing.

The Battle of Olustee was a Southern victory and a great encouragement to the Confederate side. And although supplies to its armies further north were disrupted, most of Florida remained in Confederate hands until the end of the war a year later.

The re-enactment is normally held each February.
