OPCC Board of Directors Meeting

September 21, 2021 / By Bob McKinney

Mother Nature provided rain and humidity for this meeting. Here's hoping October's meeting is more comfortable.

We started this meeting off with intentions to follow Robert's Rules of Order as the agendas have shown since my first meeting 10 years ago, but have never been followed. This will make a more orderly meeting. We understand some residents will have a difficult time with the new format, but in time, the meetings will run more smoothly. Be prepared for a learning curve.

We had a surprise guest, Paul Blackstone, COO, 121 Financial Credit Union. He spoke about the credit union's position and current offers for the golf course. His session was lengthy, and he answered any questions he could within his legal ability. This was an excellent example of why in-person attendance is critical as this article cannot contain all the issues. 121 will consider OPCC as a potential buyer, but they currently have two perhaps three offers on the table for

\$1 – 1.2 million, so our hopes for \$800,000 are remote. By the time this issue arrives, you should have had the community survey checking the community's appetite to purchase the golf course with a rough idea of the costs. We are not able to determine actual costs at this stage, but if the community does not support the lower range we are providing, there is no use doing a more comprehensive study. In that case, the board will move on to working with 121 and potential buyers to get the best deal we can.

The ARB had another busy meeting with approvals for roofs, screened rooms, and landscaping. As the weather cools down, more projects will be planned. Please remember applications must be submitted and approved prior to commencement of work.

The plans to fix the road issues at the gatehouse have hit a bump. The contractor we chose is not returning calls; perhaps this is due to staffing shortages. We are looking at other options.

Effective November 1, our new security company, Giddens Security, will take over duties from Garda. Please be patient as they make this transition.

The first draft of the 2022 budget is underway and will probably be the first of several. I expect to have an open budget meeting towards the end of October to get community input. The requirement for an increase in minimum wage is really driving the 2022 budget and we will attempt to keep the increase to a minimum.

The next meeting will be held October 19 at 6:00 p.m.

OPCCOA/LRIA Steering Committee Report

September's meeting was called to order by Tom Coppola at 6:00 p.m. There was a quorum of committee members present. The August meeting minutes and financials were unanimously accepted. The August gatehouse report was provided by Garda. The committee unanimously approved the 2022 landscape contract from Tree Amigos. It was slightly higher than the 2021 contract due to the need to increase wages. A proposal has been requested for installation of Christmas lights at the gate. Last month approval was given for the paver project at the gate. We are still waiting on the contractor to schedule the work. There was some discussion regarding issues with barcodes and gate passes. Follow up will be done with gate staff. The meeting was adjourned at 6:47 p.m. and the next meeting will be held October 21 at 6:00 p.m.

Loch Rane Board of Directors Meeting

The September meeting of the Loch Rane Board of Directors was held on September 28. It was sparsely attended by residents in person and via zoom.

The treasurer's report announced that we are still under budget for the year, which is great news. We hope to continue and parlay into additional expenses coming up for 2022.

The Steering Committee approved a bid from Giddens Security to replace GARDA after an extensive research and interview process. The plan is to have Giddens take over for Garda before the end of the year. Some existing staff will be offered to retain their positions within Giddens as part of the changeover. The increase in cost for 2022 is approximately \$86,000 dollars (split between both communities).

The resident organizing the neighborhood garage sale will soon set a date. It will should be towards the end of the year. We will announce this across all platforms once the date has been selected. Additional volunteers to help are still welcome!

We are happy to announce the completion of the 2021 Storm Drain Relining project with the completion of the very last "critical" storm drain earlier this month. This was a huge step in addressing many critical infrastructure repairs within the community, but does not even cover half the remaining storm drains in need of repair.

The CAM team should have the 2022 proposed budget available for the BOD to review and share at the October meeting. We will also be discussing the expectation of a 5% increase in dues to cover higher operating expenses next year (for instance the increase in the security contract), as well as the expectation of another special assessment to allow us to address more of the drainage and infrastructure issues that have impacted the community for quite some time. We realize that increases in dues and assessments are never welcome news, but unfortunately these projects will simply never be completed without taking these steps to fund them.

The BOD has obtained an estimate to excavate and repair the sinking road/storm drain basis at Ennis and Duart. However, before we can move forward we need to locate the source of the constant flowing water into the street on Ennis from a resident's home.

The BOD approved a bid from TOCOI engineering for plans to excavate and repair/ restore the large discharge ditch that runs behind Arran Court fed by both the retention ponds in that area. Getting plans will allow us to obtain an accurate estimate from a contractor to perform maintenance. We expect this project to be approximately \$100,000.

We have not rescheduled the underdrain installation in the swale between Cameron and Duart. Additional residents in that area have expressed concern about the swale needing repair in areas where residents have erected fences and blocked the normal surface flow of water. We will have the contractor observe this area and give an opinion on how best to address or repair these issues.

A huge shoutout to Arlene Muehl who secured and installed a complete set of windscreens for the Loch Rane courts at no cost to the community! Thank You Arlene!

The next meeting will be held on October 26.






Ladies and Gentlemen, Health is Wealth. Come join the fun.

The limited scope of the survey is to determine support for a purchase, knowing that there will be financial commitment required from the homeowners to source funds to purchase and maintain the property. If there is enough support to move forward, the Association will draft a new "offer" to submit to 121 Financial Credit Union. Please follow the instructions included with the survey and return your survey no later than October 13th so that your opinion is included in the results.
