### Commissioners, legislators demand environmental study of former Lake Asbury

Residents met to disclose illnesses they believed were related to toxic conditions 27 years ago

LAKE ASBURY – Michael Zelinka is a former employee of Solite, an aggregate kiln company that had more than 40 years at Country Road 209-A from the 1950s to the 1990s. He worked at the Lake Asbury area-based plant from 1990-1991 and 1992-1995 and resided at the nearby Russell Baptist Church, which was a half-mile from the site. He was one of the three ex-employees who provided recent testimony to the Florida Department of Environmental Protection in a phone meeting that included County Commissioner Kristen Burke, County Attorney Courtney Grimm and County Manager Howard Wanamaker.

In a recent interview with Clay Today, Zelinka provided a corroborating statement, with his claims exposing the company to several potentially heinous safety and environmental malpractices. "If you want to know anything about the

safety history of the place, it was nonexis-

# Clay County commissioners get preview of needs by CCSO, CCFR, CCEM

GREEN COVE SPRINGS – A big-ticket meeting took place between the officials and the community during the Clay County Board of County Commissioners workshop on Tuesday morning, with funding streams and five-year and 10-year project plans discussed for the following categories: capital improvement projects, mobility and impact fees, bonds, restricted fund projects and monies from American Recuse Plan Act.

One crucial item raised during the impact fee portion of the meeting was the future of the facilities for the county's police department, with Sheriff Michelle Cook speaking adamantly in an assertion the department needed an upgrade with a more centralized operation.

"I know the county was hit by some very difficult times financially and I understand. We are very flexible, fluid and operative with the county, and are trying

### Drivers take advantage of Operation Green Light to get back on the road

Program helps reduce fees, create payment plans for outstanding tickets

ORANGE PARK – Richard Edwards' luck ran out last June when he was stopped and charged for driving during the previous 18 months with a suspended license.

Mounting fees, collection costs and penalties made it more difficult for the Green Cove Springs man to pay his fine and get back on the road – legally.

Then he heard about Operation Green Light.

"I heard about it last year, but I never gave it much thought," Edwards said after he made arrangements to settle his debt and get his license reinstated during last Saturday's unique program at the Clerk's Office on Park Avenue. "I decided to check it out this year."

In the process, Edwards learned the county agreed to drop more than \$900 of his penalties. In about five minutes, he also discovered the clerks were willing to set up a payment plan to settle the original ticket.

"I couldn't believe how it turned out," Edwards said. "I realize if you don't know something, all you have to do is ask. You know, a driver's license isn't a right. It's a privilege. I know it now."

According to Chief Operations Officer Tracie McRae of the Clerk's Office, a long line of Clay County drivers was in line more than an hour before the doors opened at 8 a.m.

The Clerk's Office sent out postcards to everyone who had a delinquent ticket ahead of the program. The office also set

up 90-day payment plans for civil tickets like speeding and red-light camera violations. Criminal tickets were decided on a case-by-case basis.


"The goal is for us to set up a plan where we can help them get their tickets resolved," McRae said. "On criminal tickets, we don't want to make it impossible for them to pay. It has to be something that's not overwhelming. We want to get people back on the road." The response was so overwhelming Clerk Tara Green decided to extend the forgiveness period to regular business hours all week at the Orange Park and Green Cove Springs offices.

"By 8:30 (a.m.), there was someone at every window, and people were still waiting in line," McRae said.

More than 120 drivers had their licenses reinstated in 2019 and 2020. McRae also said there hasn't been a repeat driver since the program started in 2018.

McRae said the Clerk's Office may consider moving Operation Green Light earlier in the year when drivers are receiving their income tax refunds.

to maintain the sheriff's office needs, fire needs, county needs, and citizen needs. But we have to move forward," she said.

That's because the sheriff's department is currently paying approximately \$1 million annually to maintain the more than 20 buildings, she said, some of which are overcrowded with storage items.

Cook compared Nassau County's current use of the campus-style model as a potential path for future buildings, bringing a print-out photograph of the regional county's building with her to the meeting. a Sheriff's Operation Center and that the campus model is something that both the county police and fire departments could look further into utilizing in the future.

Cook said she would only keep necessary service deputies to operate out of substations in places like neighborhood malls, where officers spend little time with only a few employees, including an administrator and a few to complete tasks like creating fingerprint copies and filing paperwork.

At a new building, Cook would seek to

house police personnel, while the current building could be repurposed to provide more jail space for the next five to seven years. The county would hopefully seek to build a jail, which is high cost, in a 10-year or 11-year plan, where \$9 million would be set aside for the project.

Cook said she would likely need about 100,000 square feet to house her department's operations in the future. She hopes to move away from the inefficient model that leads to crowded storage areas but that the space could expand between two or three buildings.

Clay County Fire Rescue also presented their plans to build four new firehouses.

John Ward, County Director of Emergency Management, also said the issue of storage was an issue.

Among other items also discussed at the meeting were mobility fees. Projections are based on last year's data and are on target again in 2023, as demonstrated by the BCC in a slideshow. The projections are based on 1,700 homes.

Also, several necessary road and trail projects will be funded through development fees, impact fees, and mobility fees throughout the county.

### Poll: Florida voters high on recreational marijuana, school choice

Days after the start of the Legislative Session, the University of North Florida's Public Opinion Research Lab released survey results on the opinion of registered voters on a variety of topics, including the use of recreational marijuana and universal school choice.

The findings could fire up supporters of a proposed change to Florida's constitution to legalize adult personal use of marijuana. About 70% of voters said they would support such a measure, while just 29% felt harsh on the proposal.

That compares to 76% who backed the proposal when UNF polled voters last spring and is much higher than the 64% who favored legalizing recreational weed in late 2019.

The level of support could be consequential as Florida requires 60% of voters to support an amendment at the ballot box to amend the state constitution.

"Efforts to put recreational marijuana in front of voters in 2024 are in the beginning stages, but support for it is high across the political spectrum," said Dr. Michael Binder, Research Lab faculty director. "If it makes it onto the ballot next year, and that's a big 'if,' it has a good chance of reaching the 60% supermajority needed to pass."

Voters also weighed in on matters state lawmakers expect to take up in the coming weeks. While members of the state Senate debate the cost of the school voucher measures, voters seem to favor the plan regardless of a potentially high price.

Asked whether they support all K-12 students becoming eligible for public funds that cover private school tuition, about 53% voiced support and 39% expressed some level of opposition. That was after pollsters gave respondents an estimate of \$2.5 billion as the cost of such an expansion, which is much more than House estimates but more than \$1 billion less than some outside analysts expect such a program would cost.

Of note, 50% of Democrats support the plan, closely aligning with the 52% support found among Republicans. But it's voters unaffiliated with either party who show the most enthusiasm, with 58% supporting the voucher expansion and 33% strongly supporting it.


Pollsters also asked about a controversial proposal to make School Board seats into partisan positions, something that also would require amending the state constitution. But here, the 60% threshold seems a far-off target. About 65% of voters oppose such a change, and just 26% favor the

# SJR State earns military-friendly school designation

ORANGE PARK – St. Johns River State College has earned a 2023-2024 Military Friendly School designation.

Institutions earning the Military Friendly School designation were evaluated using public data sources and responses from a proprietary survey. More than 1,800 schools participated in the 2023-2024 survey, with 665 earning special awards for exceeding the standard.

The Military Friendly Schools list will be published in the May and October issue of G.I. Jobs magazine and can be found at www.militaryfriendly.com.

Schools earn the designation with input from the Military Friendly Advisory Council of independent higher education and military recruitment community leaders. Final ratings were determined by combining the institution's survey scores with the assessment of the institution's ability to meet thresholds for student retention, graduation, job placement, loan repayment, persistence (degree advancement or transfer) and loan default rates for all students and, specifically, for student veterans.

According to SJR State President Joe Pickens, the college is committed to connecting military service members, veterans and their families with the services and resources they need to reach their personal and academic goals.

"At SJR State, we understand the unique challenges Veterans face when returning to civilian life and the importance of investing in their future," Pickens said. "We recognize their service and strive daily to match that level of commitment as they transition into higher education and develop their strengths and skills into a new career path."

"Military Friendly is committed to transparency and providing consistent data-driven standards in our designation

move.

An overhaul of Florida's higher education found scant support from the public. With such proposals presented as eliminating critical race theory and ending diversity, equity and inclusion programs, 61% of voters say lawmakers should nix the plans, and only 35% embrace the change.

But there was a notably partisan split, with a majority of Republicans favoring the move.

"Despite elevated support among Republicans, many voters we spoke to are not so thrilled about some of DeSantis's most recent proposals in his war on 'woke' culture, this time targeting Florida's public colleges and universities with HB 999 and SB 266," stated Binder. "A notable chunk of Republicans (38%) don't like the restrictions, but the 56% in support reflects the likely outcome in Florida's Republican-controlled Legislature."

However, there's opposition across the board to another conservative plan moving through the Legislature with Republican support. About 77% of voters oppose permitless carry of firearms. That number is high in part to opposition from 93% of Democrats, but 62% of Republicans who want those with concealed weapons to obtain permits with the state.

"Not only is there bipartisan opposition to this 'constitutional carry' bill, but folks seem to feel passionate about it with the majority (67%) saying they strongly oppose the bill," Binder said. "Even among Republicans, most people are against carrying weapons without a permit."

Asked to prioritize what the Legislature should be working on, a full 25% of voters listed affordable housing as Florida's biggest problem. Economic issues came in second place, ranking as the top concern of 17% of voters, while 12% listed education, 10% said immigration and 7% care most about gun policy.

The poll results included responses from 1,452 registered voters surveyed between Feb. 25 and March 7. The margin of error is  $\pm$ -2.57%.

### Famed rock photographer Mark 'Weissguy' Weiss captures 'The Decade that Rocked'

JACKSONVILLE – Gallery 275 will welcome the famed 80s' rock n' roll photographer Mark "Weissguy" Weiss for a remarkable photographic journey through March 26.


The "Decade that Rocked" transports viewers back to when music was louder, spandex was tighter, and hair was bigger. Yep, we're talking about the 80s.

Weiss was a 14-year-old kid from New Jersey when he made a deal with a neighbor to cut his lawn in exchange for a 35-millimeter camera. Thus began a lifelong journey of rock and roll mayhem that continues.

"As a kid, I used to go to concerts with my brother. So I would tag along and meet all the people. That's just what we all did back then," he said.

While in high school, Mark snuck his camera into concerts, paying off security guards to get him closer to the stage. After developing prints in his parent's bathroom, he started selling illegal prints out of his school locker and in front of the concert venue for a buck a piece.

After being arrested outside of Madison Square Garden and spending the night in jail, his peddling days were over. A week later, Weiss walked into the offices of Circus Magazine, the leading rock publication at the time, with his portfolio. Circus published a centerfold of Weiss's photo of

Steven Tyler of Aerosmith in their October 1978 issue. Within a few months, he became a significant contributor to the magazine and soon became a staff member, shooting covers and features.

His photography takes a life of its own, a style he calls "smoke and gels." You can almost smell the sweat, the cigarette smoke and Jack Daniels backstage. It's fast-paced, chaotic, gritty, and surprisingly intimate. Weiss captures what no one else ever has, the moments that no one else sees.

The gallery will feature rock legends

such as Bon Jovi, Ozzy Osbourne, Guns N' Roses, Led Zeppelin, Aerosmith, Van Halen, and many more. Weiss will appear at Gallery 725 on Saturday, March 25, and Sunday, March 26, to greet fans and talk about the history behind his classic photographs.

"People want to know about my favorite work shoot, the craziest shoot, and I have answers to all of them. They want to hear the stories, my story, but what they want is a little insight into the artists, the ones that I am photographing, because I have a different relationship with the fans because

I am hands-on with them."

The legendary bands of the 80s touched on something timeless. Their larger-thanlife personalities made them enduring figures across the generations. Behind the dramatic makeup and stage costumes, they are almost godlike. While their on-stage persona never fails to impress, Wiess was more interested in capturing their backstage presence.

"On stage, they are like gods, you know? They dress like gods. That's their personas.

# **UF scientists base** international lightning research at Camp Blanding

CAMP BLANDING - Not all the loud blasts from the Camp Blanding area are military explosions. Some are part of the University of Florida's research on one of nature's most potent forces – lightning.

The university's International Center for Lightning Research and Testing was originally created after one of the state's worst droughts to find solutions for wildfires triggered by lightning strikes. But there was one problem: scientists had to wait for passing storms to do their work.

Martin Uman, chair of the College of Engineering's electrical and computer engineering department, told the university's Explore magazine his group had to create a way to accelerate Mother Nature's fury.

"It was a horror," Uman said. "We were all set to go. Everybody was there."

When storms blew through, strikes were unpredictable and lasted less than a second. Also, lightning is thunderous and 50.000 degrees.

Uman and the University of West Flor-

ida's professor of electrical engineering Doug Jordan set up a high-speed camera at Camp Blanding for optical measurements.





But he only had 15 good images after 15 vears of research.

Engineers at Florida launched skinny rockets 2,400 feet from batteries of steel tubes into a storm cloud to induce a lightning strike.

According to the university, researchers recorded as many as 35 strikes one summer by firing rockets from a 35-foot wooden structure topped by a lightning rod on the base.

Not only will ongoing research help scientists better prepare for dangerous conditions, but it can also help avoid emergencies like small airports losing power and keeping people from being killed by strikes. Each year, about 150 people die by lightning and strikes create more than \$500 million in insurance claims, according to the university.

"When we understand the mechanism, we will try to design a better lightning protection system," said Vladimir Rakov, a UF electrical and computer engineering professor.

Research at the lab has resulted in more than 100 published papers on the different aspects of lightning, mainly how electric and magnetic fields are related to currents.

Lightning research has come a long way since Benjamin Franklin tied a key to a kite he flew in a storm. The Camp Blanding facility is considered one of the premier research centers in the world.

'Every year, we're able to do fancier and fancier stuff and learn more and more than we could before," Uman told Explore.





But backstage, they are just regular people with regular emotions," he said.

# Orange Park Hospital trades syringes, bandages for PET saws, paint brushes

#### A dozen volunteers help create PET carts at Penney Farms

PENNEY FARMS – On most days, Vicki Gibbs Lee works as a Physicians Liaison at HCA Orange Park Hospital. But on Friday, March 10, she was a punch presser.

She joined a contingent from the hospital building mobility carts for Personal Energy Transportation Florida Penney Farms.

The hand-powered carts are delivered worldwide for people who struggle with mobility. More important, there is no cost for the recipients.

Orange Park Hospital colleagues spent the day working with volunteers at Penney Farms Retirement Center who built more than 14,000 carts as part of its "We Show Up for Our Communities" program.

Lee took metal blanks and pressed them into brackets that connected the scooter's shell to the floorboard.

The word seemed monotonous, but Lee quickly filled enough boxes of connectors to keep the volunteers at PET busy for months.

"It feels great," Lee said. "I really got into it."

Hospital CEO Lisa Valentine sanded the



corners of planks used on the sides of the scooters. Jennifer Estrada, Sandy George and Selma Clark were in a back room painting each cart. Estrada is the Therapy Manager for Inpatient Rehabilitation; George is the Vice President for Quality; and Clark is the director of Infection Prevention.

"They are an extraordinary group of people who really are serving a need worldwide," Valentine said. "They manufacture these. I guess what they

what they call hand-powered self-mobility.

"And they work with other sites across the US and deliver these to 120 countries worldwide, all for free for men, women and children with disabilities who are unable to walk. It was started by a missionary (and long-time Penney Farms resident Larry Hills). He served in Africa, and he saw that there were people who were unable to work, go to school, or care for their families because they simply did not have transportation."

Chief Operating Officer Pete Long'innes

worked with PET volunteer Mike Kolodka on packing the carts into a box to be shipped. Each contained the cart, seat, three wheels, a handdriven chain drive and handlebars.

"And so they were great about making sure our team could contribute in a meaningful way.

experienced space and STEM professionals whose goals are to illustrate the numerous possibilities in the world of STEM.

Through a partnership with 4-H Club. the Higher Orbits winning team of "Go for Launch! 4-H in Space" will have their experiment flown to the International Space Station. The tentative launch date was Wednesday at 8:30 pm.

Torkzad's work will study microgravity's effects on spirulina growth in space.

"I was about six or seven years old, when I started to get into science, especially biology and astronomy," Torkzad wrote on her profile at higherorbits.org.

"My seventh-grade science teacher connected me with my county Florida 4-H agent, who was looking for one more person from my county to join 4-H's collaboration with Higher Orbits, also known as Go For Launch!'

As part of the winning team, she was invited to watch the launch of SpaceX CRS-27.

"Winning was unexpected but not unwelcome," she said. "I would love to do something like that again. I can't wait to see another launch."


Not only was Torkzad the youngest person on the team, but she was also the only girl.

"Originally, we wanted to name ourselves 'Team Glasses,' but after some brainstorming, we decided to name ourselves 'Team Space Goats.' (Hints: look at the zodiac constellation Saturn in July 2022" (when they competed for a spot on SpaceX).

"I suggested the idea of an experiment with cyanobacteria after reading an article

about it being potentially used for mining on Mars a few days before," she said. "While trying not to fling my laptop across the room because of its annoying persistence to not connect to the Wi-Fi. discovered about and suggested spirulina."

Spirulina is a cyanobacterium under the category of algae and is rich in vitamins – one tablespoon contains four grams of protein. Covering the problems of a continuous supply of protein in space for long-distance trips, they found their experiment.

"When we weren't working on our experiment, 4-H organized multiple activities for the members of the other three states," Torkzad said. "My personal favorite was when some rangers brought two alligators

participated in the book drive, which also weaves in lessons of compassion, generosity and giving without expectation—the cornerstones of Primrose Schools' Balanced Learning Approach.


The enterprising preschoolers of Primrose worked with the school, their teachers, parents, and other students, making it fun by decorating their boxes and participating in story times.

tent," he said.

While working with Solite, Zelinka greased the kilns' bearings and unloaded plastic, metal and fiberglass barrels with a Bobcat machine.

Greasing the bearings required Michael to crawl dangerously into deep nooks and crannies in the ground without wearing protective gear.

"While I was down there, I felt like my skin started to burn," Zelinka said. "When I got out of there, I complained about it, but they told me it would just go away. They told me, 'It's nothing, don't worry about it.'"

The company would hide the truth from employees about the damaging effects of the reckless practices that they were performing, Zelinka said.

Zelinka wasn't the only employee without protective clothing. Instead, nobody was required to wear it. But the lies and lack of transparency went further than that, the former employee claimed.

He said one ex-employee once jumped into "the scrubber pond" to relieve the pain from the burning heat.

But then, the individual was burned even worse. He said that the pond had acid in it, which ate away at his clothes and skin.


Zelinka said potholes in the road were fixed with a contaminated pile of debris and tables where people ate on Earth Day was washed in a toxic pond, and fish and wildlife on the property would develop cancerous tumors.

Zelinka said that once, he and two coworkers took out a canoe for a fishing trip at the main lake bordering the plant on the property during a break on a night shift.

The ex-employee said that one of his coworkers took a floodlight and pointed down towards the bottom of the body of water, where he witnessed a dragline, boom arm, cars and trucks and more, which included "everything they didn't want or couldn't use anymore."

The whistleblower also claimed several other egregious evils from the company, listing several barrels buried and hidden on the property, which included a system of ponds, peninsulas and lakes utilized to hide the containers and their toxic chemicals.

Zelinka claimed barrels were buried under berms and dumped into the woods off Country Road 209-A, where homes are

now built.

He suffered from a heart attack during his first stint with the plant, and doctors also found a high level of arsenic in his blood. Zelinka isn't the only one in his family that has suffered from illness, though.

His mother, who lived a mile from the plant, died of breast cancer, and it's even possible that his 7-year-old son could be suffering from the effects of the former Solite site to this day.

Zelinka's son had 11 teeth pulled during an operation last week, and he said another child died at birth.

The problems of Michael and his family could be the beginning of health and safety risks linked to the plant that closed more than 27 years ago.

The plight of residents in the area has attracted the attention of representatives from the Florida House and the Senate.

"I want to make sure our county and the land owners (in the area) get the information for every bit of information we need," said Florida Rep. Sam Garrison (R-Fleming Island). "At some point, the (Department of Environmental Protection) made the determination nothing should happen there. The order should stay in place. Period.

"We need to be 100% certain there is no danger to the community. We need to err on the side of caution."

On Feb. 21, Burke hosted a private meeting at Russell Baptist for those in the area whose health has been negatively affected could have the opportunity to meet. Each individual could see where they lived compared to the former plant, the diseases they contracted, and the year in which they were diagnosed. She also received their input on other people who have passed away, and the illnesses they lived with and pinpointed their former residence concerning Solite.

Burke is also seeking out a class-action lawsuit for residents and considering hiring an attorney.

Stoneridge Farms, a shell company with the same address as Solite, is not allowed to build homes on the approximately 900-acre property.

That's because the Clay County Board of Commissioners unanimously passed a measure placing a moratorium on the rezoning of the property on Nov. 23, 2021, for one year. That moratorium was extended during the BCC's meeting on Nov. 22 meeting, which denied Stoneridge Farms an opportunity to seek residential zoning for at least the remainder of this year.

The property is currently zoned as "So-lite."

No one can stop Stoneridge Farms from conducting a sale of the property, but Burke said that her top priority is to continually do everything in her power to stop Solite from being taken off of the consent order for the entire property and hold the company responsible for the testing of the remainder of the property, which totals approximately 700 acres.

"We need the consent order to clean the entire 900 acres until the 'clean' 600 acres are tested due to the evidence we have provided to FDEP of the entire property, and Solite should be responsible until testing and cleanup are complete," Burke said.

Along with the moratorium, BCC is also seeking to help residents, which they expressed in a two-page email sent to the FDEP on March 2. The email was addressed to FDEP secretary Shawn Hamilton and Environmental Administrator Michelle Smith and aimed to address vast concerns relating to the parcel.

"We request that the FDEP take every step to ensure the safety of Clay County citizens and our environment. To that end, our request specifically includes the updated testing for the 600 acres and financial assurance for the cleanup of the 264 acres and the possible cleanup of the 600 acres," the end of the letter reads, which is signed by Board Chairman Betsy Condon.

Florida Sen. Jennifer Bradley (R-Fleming Island) has also been working with Burke and Grimm to ensure the property won't be developed until a review is completed. The group will meet with Garrison and the FDEP this week to determine if new evidence of contamination has been found.

Thus far, the FDEP's only knowledge of contamination has existed in the portion of the property estimated at 200-264 acres where former tests have already detected arsenic, lead and cyanide in the soil.

Solite would likely seek to have the consent order reassigned to Danhour Group CEO Michael Danhour, so they could potentially begin excavating the land.

Danhour, who has long been part of the process, is the likely buyer Stoneridge is seeking to sell the land to, which is information that was confirmed by the DEP in a phone call with Burke three weeks ago.

Burke reiterates her belief that Stoneridge Farms would seek to cut the timber. If work were to be done, it's possible chemicals could be jarred loose and released into the atmosphere.

"As far as we were told by the FDEP, if the consent order was released from the 600 acres, this would not stop them from excavating and cutting down the trees and doing everything they want to. They want to make money on it. They're just going to drain the property of any kind of value they can get from it and leave. That's definitely our concern," she said.

## St. Mary's Shoals Park: "The Gem of Northeast Florida"

GLEN ST. MARY – "We've got 26,042 acres," said St. Mary's Shoals Park Patroller Steve Harvey. "It's divided basically in half."

According to the St. Mary Shoals Park website, the park encompasses separate facilities and trail systems for OHV operators and "EQUI-PED(AL)" visitors, referring to equestrian and pedestrian guests, hikers, cyclists and any other foot traffic.

"Once you go down the bridge, everything is basically ATV, side-by-sides and motorized vehicles. We have 24.2 miles of motorcycle trails and 22.6 miles of pedestrian and equestrian trails and bicycle trails," Harvey said.

St. Mary's Shoals Park has preserved what old Florida looked like a century ago, complete with Spanish-moss-draped ancient and downed trees, and fish ponds home to catfish, bass and perch. The area has lots of wildlife, from turkeys, deer, some hogs and the occasional black bear, although Harvey said bears have never been a problem for park visitors.

"They are mostly scared of people, so they don't wander into the park too often," he said.


The park opened in 2009 and has operated through various grant funding, including the Florida Communities Trust, FRDAP, and Recreational Trails Program. "Then they added the ATV side later in 2010," Harvey said. The property is located along the Florida-Georgia border and is flanked by the St. Mary's River on its northern boundary. EQUI-PED(AL) visitors are restricted to the park's eastern section. Entrance to this facility is located at 7777 Odis Yarborough Road. OHV operators are restricted to the park's western section at 7867 Odis Yarborough Road.

"The ATV side is open Friday, Saturday, Sunday and Monday. The walking side is open seven days a week, morning to dusk," Harvey said. The park closes 40 minutes before sunset.

Park visitation costs \$5 a day for passenger vehicles and vehicles with trailers and off-highway vehicles (OHV/ATV). Commercial vehicles carrying more than 10 persons is \$50 per day. Annual passes are available for \$30 per vehicle, or \$25 for Veterans and Seniors.

Besides single and multitrack riding and pedestrian and horse trails, there are many activities for families to enjoy, including nearly two miles of the tanninstained St. Mary's River and white sandy shores. "We also have access to Cedar Creek," Harvey said.

So what exactly is there to do at the river?



"We're just now letting people bring their kayaks to designated kayak launch points to enjoy the river," he said.

Besides kayaking, shallow banks make for a perfect area to wade in or go for a swim. If you feel like relaxing for a while, then there are plenty of places with wide sandy banks to put out a towel and sunbathe.

In addition to the various ponds scattered across the park, fishing is also available anywhere along the banks of the St. Mary's River or Ceder Creek, which runs through the middle of the park.

Other amenities include pavilions, restrooms and water access for public use. St. Mary's Shoals Park is also the largest

off-highway geocaching location in Baker County. With 2,568 acres, the county website calls it a "geocaching paradise."

Geocaching is a treasure-hunting game where you use a GPS to hide and seek containers around the property, usually with other participants. However, it's not a race but a nice walk for everyone to enjoy the area where much wildlife can be seen. And there is much more to look forward to, Harvey said.

"We are currently working with the county manager to let people camp on the property. The county is on board with it on a limited basis on primitive camping."

Although camping is not permitted on



the premises, a short drive to Ocean Pond Campground in Sanderson does have firstcome, first-serve amenities with water and electrical hookups.



There are two separate sections of the park; one for foot traffic (both two and four-legged) and one for ATVs. The pedestrian side is open seven days a week, dawn to dusk. The ATV trails are open Friday, Saturdya, Sunday and Monday. There is a separate entrance to the ATV park.

# **Finally, closure...** Family, friends remained vigilant after Michael Jackson sentenced to life

GREEN COVE SPRINGS – After a prolonged trial that has taken a winding road of twists and turns since Jan. 4, 2007, Micheal Renard Jackson was finally sentenced to life in prison without parole for committing the brutal murder and rape of 25-year-old Andrea Boyer.

Jackson was formally sentenced – for a second time – at the Clay County Courthouse on a rainy, dreary, last Monday on stormy Monday afternoon.

While finally punished and locked away forever, Jackson's trial put the victim's family through two torturous trials in the past 18 years after he initially was sentenced to death for the heinous, criminal, violent act.

Justice was finally served in the county after more than 16 years in a trial that encompassed a large portion of the lives of many of Boyer's family members and friends. Still, it didn't come without plenty of emotional wear and tear along the way for those close to her.

"I'm a little bit melancholy right now because (the trial) has defined a huge portion of my life. I was 18 when this happened and I'm 34 now. My entire adulthood was consumed by this, and my career was defined by this monster (Jackson). Now, we can all move a little bit forward," said Heather Rich, Shad Boyer's sister.

It didn't take long to get to the point

during the first trial. The jury only spent 90 minutes to render a guilty verdict. However, the Florida Supreme Court tossed out the verdict after discovering that county deputies made prejudicial comments while on the stand. The COVID-19 pandemic slowed down his trial. as well.

According to Assistant State Attorney Daniel Skinner, this was one of the biggest challenges of the trial for Boyer's loved ones.

"That was the biggest struggle in the case, the long and lengthy period that it took for the trial. Our hearts broke for Shad Boyer's and Andrea Boyer's families, as far as the state was concerned " he said.

Rich said Skinner was integral in the case.

"(Daniel's) role was integral to making sure all of this was successful. Without him, I don't think our family would have been able to make it through 16 years of this. The fact that he has been with us from the very beginning is incredibly uncommon with how many prosecutors come and go and how cases change hands," Rich said.

She described the family-like bond he fostered with both sides of the Boyer family as the "glue that made it all stick together."

Boyer's mother and father, who have been in Washington together recently, were able to hear Jackson's guilty verdict together on Feb. 18.

"He was able to hear that verdict, which was able to bring him peace and hope," Skinner said.

Dr. Michal Harris, a co-worker and close friend of Boyer's, was one of two that provided a closing victim statement, along with Boyer's niece, Kayli Latner.

Harris said Boyer's death significantly changed the course of the lives of those involved with the case, providing her with increased resilience, care for those around her, and appreciation of everyday life.

"In a very strange way, I think it puts things in a proper perspective for her. If I can live through that, a business can survive that, and a community could lift a business the same way that Clay County lifted the veterinarians' hospital after that happened. It's almost difficult for me to get mad about some things that we get upset about in our daily lives," she said.

But most important: "I'm just really glad that I'll never be in the same room with Micheal R. Jackson for the rest of my life. That will be a very happy thing for me. I think we're all pretty happy to close this chapter and move on," Harris said.

Jackson spent nearly 20 years in the justice system before finally being sentenced to life in prison. He was on probation for a previous rape when he raped and killed Boyer.

"Michael Jackson has again been convicted of murder and sexual assault and will spend the rest of his life in prison. This was a long journey to justice for Andrea Boyer's family, friends, and the community and result of the commitment of the Clay County Sheriff's Office, the Florida Department of Law Enforcement, and our prosecutorial team," said State Attorney Melissa Nelson.

Meanwhile, Boyer impacts lives every day. Harris said she posted information about the case to a large online veterinary group with about 65,000 international members. Since then her case has had an immense worldwide impact on the safety of modern veterinary hospitals.

"I can honestly say that what had happened to Andrea has helped change security in the office in probably every country on the planet, and that's pretty cool," Harris said.

Rich, who works in law enforcement, said that the trickle-down effect could affect hundreds to thousands of lives because the case can be used as a teaching moment on investigating homicides in the modern day and the future.

# Dry in Stride keeps Gate River Run dry

OAKLEAF - Runners at the week long Gate River Run 15K expo are always on the hunt for the latest techno shoe, or supercool sunglasses or high-tech wrist watch.

From their living room in Oakleaf, packed with a dozen moving boxes with their invention, Sara Slettebo, a frequent gym and running athlete, decided she was just tired of having to grab a towel, use her sweaty shirt or just wisk away sweat from her brow with her even sweatier hand.

"I was tired of forgetting my towels for the gym or using my yucky shirt to wipe my face and decided to invent something," said Slettebo, who claimed husband Kelly was the "reality" check for her numerous invention ideas. "Every athlete has had to find a towel in the middle of a workout and it is usually on the floor or stuffed in the gym bag or in the waist band of sweaty shorts."

Slettebo's answer, seven years after prototyping one of the more unique ideas that launched at the Gate River Run expo last week, was her Dry in Stride retractable towel. Note: Two Dry in Strides were sold right as this interview was being done at the Gate River Run expo.

"We figured since the Gate River Run has inspired us to run; husband Kelly, and millions of others, what better way to validate our idea," said Slettebo, noting her Gate River Run price of two towels; 10 inch by 10 inch or 13 x 13, for \$15.99 was crazy popular. "The response has been overwhelming almost to the point that we now may have to move out of our living room. We sold everything we carried in plus had people find us after the race to ask where more could be bought. Crazy."

Slettebo's original idea; noting she

called herself a serial entrepeneur as far back as a handheld soap contraption in elementary school, was to make a fabric that was a super towel that was attached and hard to lose.

"It is attached to your shorts or shirt or a pocket, it is reusable and it is made of a bamboo fiber that is quick to dry," said Slettebo. "We are patent pending with the bamboo towel being about five times more absorbent than a cotton towel."

Slettebo also mentioned that the bamboo construction has an added bonus of being sustainable.

"Some bamboo is grown as fast as three feet per day," said Slettebo.

The retractable reel that attaches to any belt or the elastic band of workout clothes is similar to an identification sling or a small key ring sling. The towel itself has a snap in the center that attaches to the reel's line.

"The towels retract about three and half feet," said Slettebo. "If you need to reach your face, your legs or even a child's face in the stroller, it can reach."

The early beginnings of the Dry in Stride idea took about a year for Slettebo to get the right idea on paper, engineered and market tested.

"I had great friends that chipped in ideas as to the heaviness of the clip, the fabrics, the type of clip so it stays on the person and doesn't fall off and then we started making them in our dining room," said Slettebo, noting 50 different fabrics were tried. "We are now at the point where our manufacturer is going to start making them with three more color patterns and we will probably expand some of the ideas for different applications like auto mechanics, health professions and golfers and even Jaguars games."



The bins are then securely transported to the Shred for Good facility, where it is destroyed.

Shred for Good rolled out a rebooted Residential Shred Drop Off Program in October 2020. On the first day, 92 households were able to destroy 5,116 pounds of sensitive materials in just two hours. Residential consumers now follow the signs to the drop zone, complete a short form, donate and drive away without ever having to leave their vehicle. To save even more time, both the form and donation have been made available in advance online. Considering that most drop-off shred sites charge more than \$.50 a pound; the Shred for Good's Residential Shred Drop-Off Program at \$.26/pound is a cost-effective alternative for the community it serves.


